

Waiver and Release

I wish to participate in the Walk A Mile In Her Shoe®: The International Men's March to Stop Rape, Sexual Assault and Violence ("Event"). I understand that there are risks and dangers inherent in participating in the Event. I understand that I am solely responsible for my health and safety, and I acknowledge that I am physically capable of participating in and completing this Event.

I understand that in order to be allowed to participate in the Event, I agree to assume all risks and to indemnify and hold harmless Missouri Shores Domestic Violence Center and its officers, agent, employees, assigns, successor in interest, contractors, vendors (and their agents), agencies, sponsors, officials and volunteers, including walk leaders, participating communities and clubs and all governmental and public entities including, but not limited to the State, County, and local municipalities where the Event takes place (collectively the "Released Parties").

I intend this Waiver and Release to release, in advance, and to waive my rights and discharge all of the persons and entities mentioned above from any and all claims for damages for death, personal injury, or property damage which I may have, or which may hereafter accrue to me as a result of my participation in the Event, even though this liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective property or equipment owned, maintained or controlled by them or because of their possible liability without fault. I understand that this Waiver and Release is binding on my heirs, assignees, and legal representatives.

If, despite this release I or anyone on my behalf, makes a claim against any of the Released Entities named above, I agree to defend, indemnify, and save and hold harmless the Released Parties from any litigation expenses, attorney fees, loss, liability, damage, or cost that they may incur due to the claim made against any of the Released Parties, whether the claim is based on the negligence of the Released Parties or otherwise.

I agree to allow the Released Parties and their contractors, agencies, or sponsors, the use of my name and likeness in connection with the Event for any purpose related to advertising or promotion of the event worldwide in perpetuity in all forms of media now and forever known.

Should any portion of the Waiver and Release be judicially determined invalid, voidable, or unenforceable, for any reason, such portion of this Waiver and Release shall be severable from the remaining portions herein and the invalidity, voidability, or unenforceability thereof shall not affect the validity, effect, enforceability, or interpretation of the remaining provisions of the Waiver and Release.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
